Application for Annual Practising Certificate for 2020/21

I write to inform you that your annual practising certificate for the year 2019/20 will expire on 30 June 2020. If you will be practising beyond that date, you are required to apply for your 2020/21 certificate.

Arrangement for application of annual practising certificate for 2020/21

- To apply for the annual practising certificate for 2020/21, please note the following application procedures –
 - You should pay the prescribed fee in accordance with the instructions on the attached General Demand Note **on or before 30 June 2020**. You may wish to note that apart from the conventional channels of paying fee, you can from now on bring your General Demand Note to pay in cash at any 7-Eleven, Circle K, VanGO Convenience Store and China Resources Vanguard Supermarket. No payment will be accepted by the Central Registration Office ("CRO") irrespective of whether it is made by post or in person.
 - After payment, you should submit (by fax or by post) the enclosed declaration form to the CRO **on or before 30 June 2020**.
 - Your 2020/21 annual practising certificate will be sent by registered post to your corresponding address. Please make sure that your correspondence address is up-to-date. If your correspondence address is changed, please complete **Form A** and return it together with your declaration form. Please inform the Secretariat of any change in your practising address by using the same form.

Application for Annual Practising Certificate for 2025/26

I am writing to inform you that your annual practising certificate for the year 2024/25 will expire on 30 June 2025. If you would continue practising beyond this date, you are required to apply for your 2025/26 practising certificate.

Full Digitalisation of Application Process for the 2025/26 Annual Practising Certificate

2. To enhance the efficiency and quality of our services in alignment with the digital government initiative, applications for the annual practising certificate will be processed electronically exclusively starting this year. Enclosed with this letter (in Annex) is a personalised QR Code that you can scan to access the online application platform. This will enable you to complete your application, make the necessary declarations, and settle the prescribed fees electronically.

3. To facilitate this e-Application process, we kindly request that you

- Download the "iAM Smart" mobile app (ver 3.5.0 or above) AND
- Register for "iAM Smart"

The "iAM Smart+" mobile app serves as a one-stop platform for personalised digital services, allowing you to log in and manage your applications conveniently from your mobile device. The registration for "iAM Smart+" can be completed in four simple steps. A leaflet containing instructions for registration for "iAM Smart+" as well as its popular and thematic services covered is attached for your easy reference.

4. The Supplementary Medical Professions Council and the Board strongly encourage all registrants to utilize the electronic application process. Recognising that some individuals may face challenges in transitioning to the online application system, should you require any assistance, you may submit a request detailing your circumstances to the Central Registration Office (CRO) by post at 17/F, Wu Chung House, 213 Queen's Road East, Wan Chai, Hong Kong. To facilitate us in handling your request, please provide your day time contact information in case we need to seek clarifications. Kindly note that the processing time for paper applications will be longer.

Updating Personal Information

5. For effective communication, it is essential that your personal particulars such as correspondence address, practising address, and email address are up-to-date. If there have been any changes to your particulars, please update the Board by submitting the "Change of Personal Particulars" online form using the QR code in the Annex.

Non-renewal of annual practising certificate for 2025/26

6. Section 16(1) of the Ordinance stipulates that a registered medical laboratory technologist shall not practise the profession in Hong Kong unless he is the holder of a practising certificate which is then in force. It is a criminal offence under section 21(1) of the Ordinance for a person whose name is not on the register to practise the medical laboratory technologist profession. The offence is punishable by a fine at level 2 and imprisonment for 6 months. If you wish to continue practising the profession in Hong Kong in 2025/26, you are required to apply for your 2025/26 practising certificate. Under section 10(4)(d) of the Ordinance, the Medical Laboratory Technologists Board may direct the removal from the register of the name of any medical laboratory technologist who is not practising his profession in Hong Kong.

7. In view of the above provisions, if you do not apply for the 2025/26 practising certificate nor notify us of your intention to continue practising beyond the expiry of your current certificate, we will assume that you are not practising as a medical laboratory technologist in Hong Kong for the purpose of section 10(4)(d) of the Ordinance and the Board would proceed with removing your name from the register without further notice.

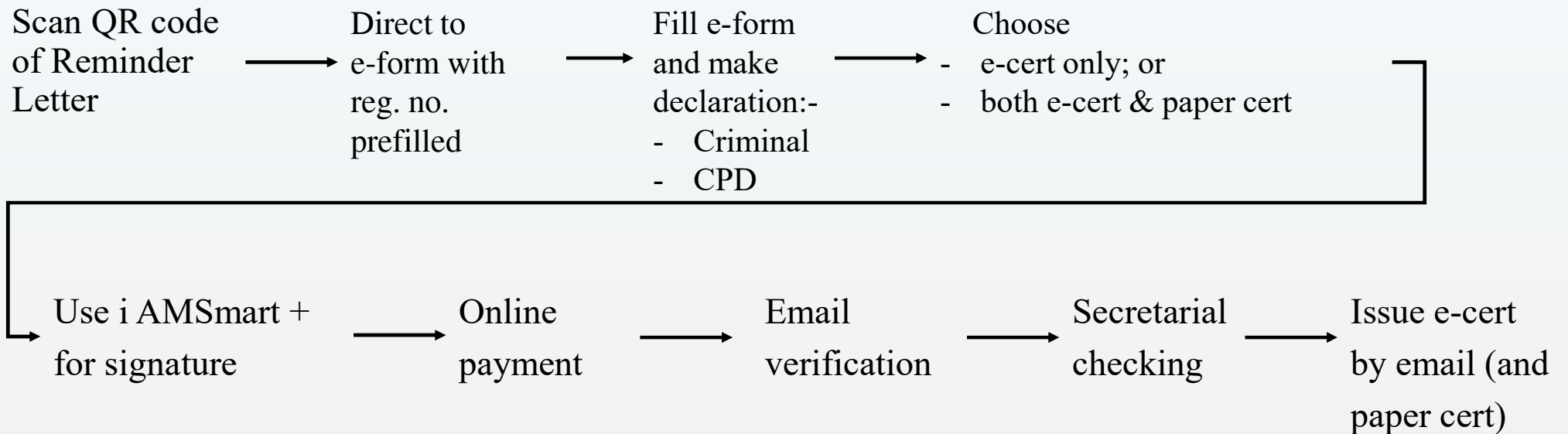

Registration Steps

1. Open the "iAM Smart" mobile app
2. Select "Start Quick Registration"
3. Select "Adult (Aged 18 or over)"
4. Read and agree the "Declaration of the Applicant" carefully
5. Select "Start", enable voice navigation when scanning Hong Kong Identity Card (HKIC) and facial identification if needed
6. Capture the front side of HKIC
7. Place the HKIC close to the NFC antenna position of your mobile phone and hold it for about 8 seconds until the data reading is completed
8. Align your face with the photo frame on the screen and follow instructions to complete the actions for real

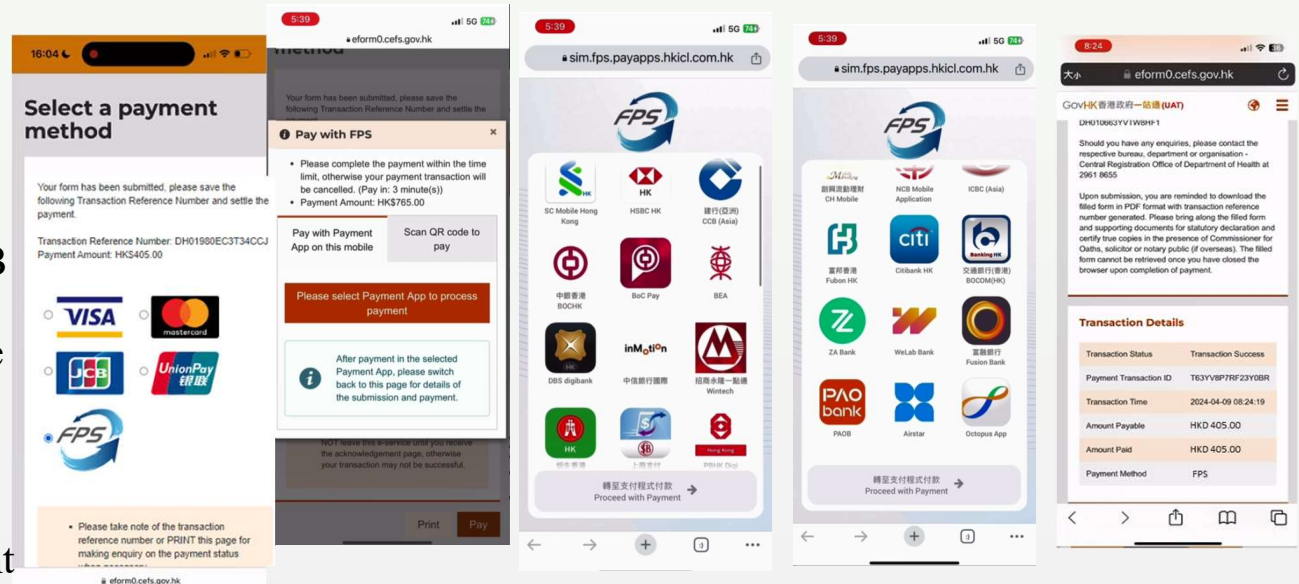
Online Payment Options

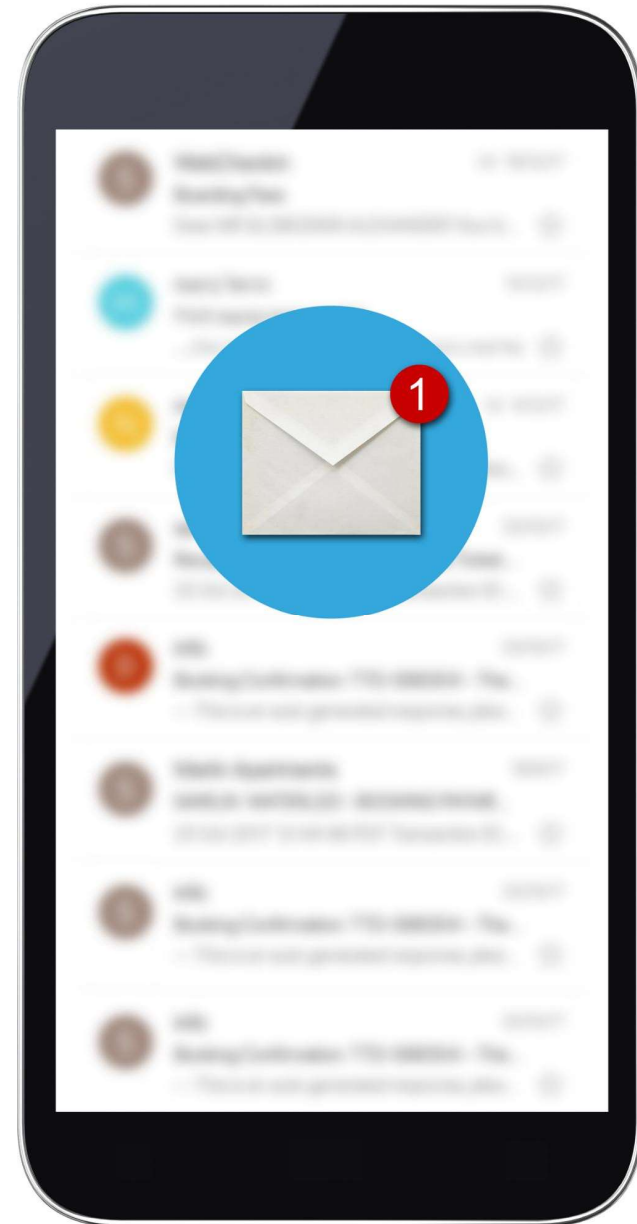

Authentication – (A) QR Code

Step 1: Scan the QR code given in the bottom left corner

Step 2: check whether it is directed to the website of respective Boards / Councils (e.g. Medical Council of Hong Kong) to ensure it is not fabricated

Step 3: check whether the information shown on the website is the same as those given in eCert



Authentication – (B) e-Signature

Step 1: Open the eCert (PDF file), click on ‘簽名面板 Signature Panel’

Step 2: check whether the signature is valid; and

Step 3: check whether the signature is made by DH to ensure it is not fabricated

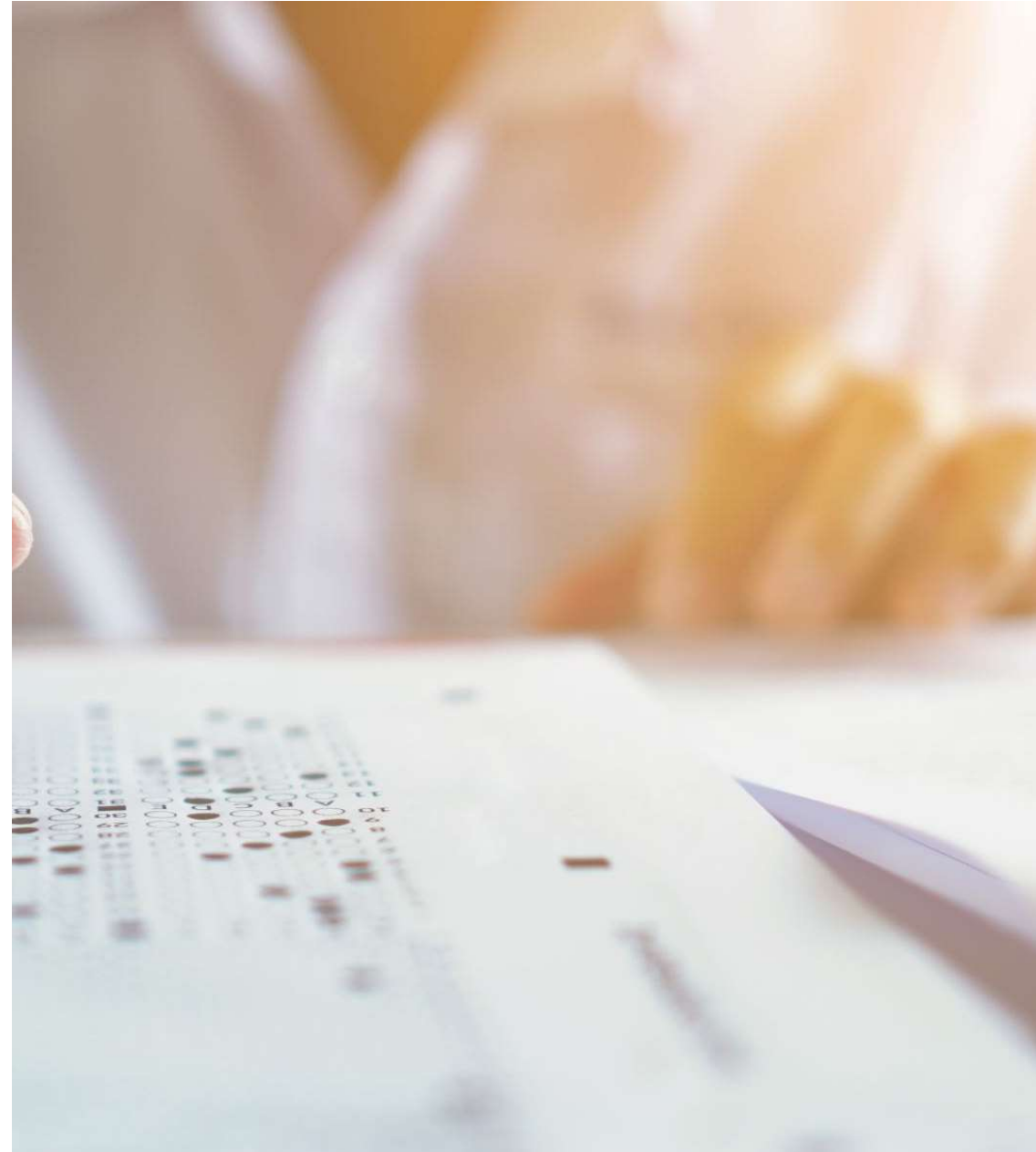


How can I obtain paper form?
Can I get it from website?

- The paper form is no longer available on website.
- You are required to write a letter or an email to Central Registration Office of Department of Health for requesting the paper form which will then be delivered to your registered address by post.

Can I pay by cheque?

- Cheque is acceptable only on exceptional case.
- You are encouraged to pay by online payment or Government Demand Note (GDN).



What is the difference between making an application for practising certificate in paper format and via the online platform?

- In comparison to application in paper format, the online platform provides applicants with more efficient and convenient services. It enables applicants to settle the prescribed fees by making online payment through some commonly used electronic payment methods.
- Applicant who makes application via the online platform will be issued with an electronic version of practising certificate (“e-certificate”) in Portable Document Format (“PDF”) by email. He / she may also request to be provided with a hard copy of the practising / retention certificate (“paper certificate”). Applicant applying in paper format will receive a paper certificate by post.
